DISTRICT TREASURERS: Cash Flow Statement (D-1 or D-1 EZ) is due to Past State Treasurer, Teresa (Terri) Thompson by June 30, 2022.

Directions for chapter treasurer to file the 990-N IRS e-Postcard and the 990 EZ FAQs document that has the link to the IRS website.

Go to the International website - www.alphadeltakappa.org - log in. At the top right there is a tab - Members Only. Hover over it and then click the tab - Resource Library. A new screen pops up. Find the Chapter Officers (near the middle of the page) tab. Click it. Three columns will pop up. Go over to the third column - Chapter Documents & Forms. Scroll all the way down to Chapter Financial Forms. Click on the 990 EZ FAQs. This document will walk you through filling the 990-N IRS e-Postcard process. The 990 EZ FAQs document is attached to the email being sent with the newsletter for your convenience.
